\*\*\* **Notes:** All fees are non-refundable, Rain or Shine. Approval of all booths will be based upon space availability and at the discretion of the Festival Committee. \*\*\* **Registration Deadline:** February 28, 2025.

**GENERAL INFORMATION**

- Each vendor is responsible for his or her displays and booth necessities (i.e. tent, tables, chairs).
- **We reserve the right to refuse ANY items or materials that could be viewed as potentially harmful or offensive as we strive to maintain a family environment.**
- This year, assigned booth numbers will be sent out mid-March.
- Registration forms will not be accepted without payment attached. Please note that NO FOOD VENDOR ENTRIES will be accepted after the February 28, 2025 deadline. All other vendor deadlines will be March 21, 2025.
- **At check-in vendors will be directed to their booth location.**

**FOOD VENDORS**

- Food Vendors will incur a fee of \$150 per booth.
- A Temporary Food Service Permit is required by the county and will cost \$50.00. (It is very important that you make sure you contact the Gaston County Health Department and adhere to their guidelines as it pertains to fees, deadlines, and more.)
- Food Vendors are subject to an inspection day of the festival by a Health Inspector..
- Cut Off for Food Vendor applications is February 28, 2025.
- We ask that vendors are completely set up and vehicles moved from the vendor area no later by 10 a.m. on the morning of the festival.
- Vendors may request to set up on Friday night by talking to Cory Johnson, the food vendor chair, for approval.



### **RETAIL/NOVELTY**

- Vendors will incur a fee of \$100 per booth.
- Move in starts at 7 a.m. and vendors must be set up and ready for inspection by 9:30 a.m.

### **ARTISAN/CRAFTERS**

- Vendors will incur a fee of \$60.00 per booth.
- To be classified in this group, items must be handcrafted by the vendor. Vendors **MUST** submit a photo with their application.
- Move in starts at 7am, and vendors must be set up and ready for inspection by 9:30 am.

### **DIRECT SALES**

- Vendors will incur a fee of \$75.00 per booth.
- Booths may **not** be shared.
- Limited to one representative per Direct Sales Company.
- Vendors must submit Sales Company set up approval with application.
- Move in starts at 7am. Vendors must be set up and ready for inspection by 9:30am.

### **EXHIBIT / INFORMATION BOOTH**

- Exhibit and Information booths are for vendors who wish to hand out information or set up a display. These booths incur a fee of \$50.00. Vendors may not sell anything from these booths. Please provide information on your display.on.

### **NON-PROFIT/HEALTHCARE TENT BOOTH**

- Non-Profit vendors will incur a fee of \$40 per booth.
- Bake sale items are permitted at these booths.
- You must submit proof that you are a non-profit entity (501c3, etc.). Necessary documentation of non-profit status **MUST** be provided with your application.
- **If a non-profit vendor cooks on-site, they will be considered a food vendor and incur a fee of \$150 for a 10x10 booth space. Vendors must also contact the Environmental Health Specialist at the Gaston County Department of Health by calling 704-853-5000 regarding the temporary service food permit guidelines and rules as they pertain to non-profits.**



**SIP -N- SAVOR MUSIC FEST BOOTH**

- These booths are limited sponsored booths that incur no charge for the vendor. As such the vendor **MUST** adhere to the rules.
- Vendors of these booths must sell Festival products only (i. e. baked goods, foods, Beverages) in exchange for a percentage of sales. Must be a non-profit, contact us if interested.
